## New bus services connecting communities in North Northamptonshire

New bus services are being introduced across the North Northamptonshire Council area for help residents travel to work or school, for shopping or leisure.

The new services have been subsidised by the council from its own budgets, through funding from the government's Bus Service Improvement Programme and from developer contributions.

The funding has been used to provide new bus services to a number of communities and to enhance some existing services on the network.

The move supports the council's Bus Service Improvement Plan which was recently approved by Executive.

Well-connected communities help develop social cohesion and are vital component in assisting economic growth and workforce mobility.

Buses play a major role in reducing congestion on our roads, reducing pollution and helping us meet our ambitious carbon reduction targets.

## **New Corby community space officially opens**

North Northamptonshire Council has opened a new community outdoor hub in Corby.

Following the success of the Corby Woodland Project, the Corby Growing Project has developed a new outdoor green space in the Coronation Park Pavilion to enable residents to come together socially.

The Corby Woodland Project has been caring for Corby's woodland areas for around two decades. While the majority of the dedicated team of volunteers enjoy outdoor and social activities, not all of them are able to take part in coppicing or the more physical activities.

Following interest from volunteers wishing to grow plants and support more local causes, the Corby Growing Project was established, with support from the National Lottery Heritage Fund.

The hub has now developed following requests to host yoga, wellbeing sessions and youth groups.

The site was opened last week by the Chair of North Northamptonshire Council, Lora Lawman. Also in attendance were Lee Barron, Corby and East Northamptonshire MP and Adele Wylie, Chief Executive at North Northamptonshire Council. Councillors from North Northamptonshire Council also attended: Cllr Gill Mercer, Executive Member for Adults, Health and Wellbeing, Cllr Harriet Pentland, Executive Member for Climate and Green Environment and Cllr Graham Lawman.

Thank you to the National Lottery Heritage Fund, the David Cock Foundation and ReGen for the generous donations that have contributed to the success of various projects across the site.

## **Work to tackle Ash Dieback continues in North Northamptonshire Council parks**

Due to a fungal disease which affects ash trees across the UK, North Northamptonshire Council will re-start work from early October - after the end of the nesting season - to remove potentially hazardous trees from several council-owned parks and green spaces.

Ash Dieback is a fungal disease which it is estimated will result in the loss of a large proportion of ash trees across the UK. Across the country, there is ongoing work to ensure that all trees are as safe as possible and the work in North Northamptonshire has been carefully considered, following national guidance, consultation with experts and with due diligence.

All work being completed is following guidance from DEFRA, the Tree Council, the Woodland Trust and the Forestry Commission.

Instead of mass felling, the council is taking a considered approach, removing individual, infected trees from King's Wood Local Nature Reserve, Irchester Country Park and East Carlton Countryside Park.

Work started on this project last year and this winter the total number of trees which will be felled is about 35 predominately in King's Wood Local Nature Reserve. A proportion of the felled timber will be repurposed for habitat piles and the rest will replenish the firewood stock, which provides an income for the parks and woodland service.

Firstly, any trees that pose a high health and safety risk by footpaths, highways and housing will be removed. By removing these trees, sunlight will be able to reach the woodland floor, encouraging new growth of flowers and other vegetation, which will support butterflies and other invertebrates. Doing this will not only make the woodland safer, but it will also make it more diverse and encourage a wider variety of wildlife into the area.

Felling and leaving diseased timber in situ is not a threat to other species but will have a high habitat value and such will be cut into 1m to 2m lengths and stacked up to create log piles, creating small habitats for newts, invertebrates and small mammals to hibernate or use as cover.

Work will start from early October, and it is estimated that it will take about two months to complete.

## **Apply now for energy-saving upgrade grant for homes with off-grid gas heating systems**

Earlier this year, North Northamptonshire Council announced the Home Upgrade Grant (HUG2) - a scheme that provides free energy-saving upgrades to residents with off-gas heating systems.

Applications are open until Monday 30 September 2024 to allow for any approved works to be completed before the scheme ends in March 2025.

Improvements could include insulation or ventilation upgrades, solar panels or a low carbon heating system.

Funding is open to private tenants, landlords and homeowners - and could help you to use less energy, reduce your carbon footprint and spend less on your energy bills.

The grant is available to households meeting specific criteria, including not being heated by mains gas, having a combined annual income of less than £36,000, and having a home that an Energy Performance Certificate declares as 'hard to heat.'

Landlords are also encouraged to apply, subject to eligibility.

The HUG2 scheme aims to phase out the use of fossil fuel heating, supporting the UK's 2050 Net Zero commitment, and promoting household health and wellbeing through the reduction of cold homes.

This is a fantastic opportunity so please check if you are eligible to apply.

## **Climate change framework and climate change attitudes and behaviours**

Residents are being asked to have their say on the council's draft climate change framework.

The draft framework will be used to inform the council's Climate Change Strategy, and outlines the council's vision, approach and key areas of focus to address the effects of climate change over the next six years.

The framework identifies six key areas of focus that climate change could impact in North Northamptonshire: Transport, Homes and the Built Environment, Nature, Food and Farming, Energy, Green Economy and Waste.

Running parallel to this consultation is another survey which asks people for more general views on their attitudes and behaviours on climate change. Responses from this survey will also be used to help shape the strategy.

## **Views sought on final proposals for improving walking and cycling routes in Wellingborough, Rushden, Higham Ferrers and Raunds areas**

North Northamptonshire Council is asking residents to give their views on final draft proposals for a strategy to shape walking, wheeling and cycling routes in Wellingborough, Rushden, Higham Ferrers and Raunds and the surrounding rural areas.

Known as a Local Cycling and Walking Infrastructure Plan (LCWIP) the blueprint will provide a strategic approach to identifying cycling and walking improvements at a local level, enabling a long-term approach to developing networks for the next ten years.

The LCWIP also forms a vital part of the government's strategy to increase the number of trips made on foot or by cycle.

By creating a good network plan for safe walking, wheeling, cycling and scooting in the area, the council will also be in a stronger position to bid for (and win) government funding or acquire funding from other sources to implement these changes.

Originally, there was early engagement with the local community and other stakeholders to develop initial ideas covering specific routes across the area.

After preliminary consultation on these suggestions in May this year, feedback and views were then taken into consideration to further refine the proposals.

A good network gives local people of all ages and abilities better options on how to travel for everyday journeys such as to work, education, healthcare, shopping, social or leisure activities. It will help reduce carbon emissions, reduce wear on roads and congestion, improve air quality, improve access, boost health and wellbeing and improve quality of life for everyone.

The consultation on these final proposals will run until Sunday 27 October.
